The financial health of the parish looks pretty good, but that can be deceiving. We were able to pay off our loan last November. That monthly payment came from the payment we get each month from the land lease of the property next door (1717 Rhode Island Avenue). We now get the full 50% of the rental amount, the diocese gets the other 50%. That has helped tremendously. The collections have remained stable, thanks to Faith Direct.

However, yes, however. The Cardinal just announced that our archdiocesan assessment will be adjusted. Up to this point we were assessed on the Offertory and Maintenance collections only. Now Holy Days, Christmas, Easter contributions and donations will be included, as well as those amounts not earmarked for a specific purpose. The new assessment rate for St. Matthew's will be 14%. A few items will have a reduced rate. This plan will start July 1, 2025.

With the new assessments I know I can depend on your generosity. I can count on you. Your donations do make a difference. I really appreciate all who contribute generously each week. If you don't give regularly, may I ask that you take the first step and give whatever you can. Others may want to think about giving just a little more.

Thank you. Your support fills me with gratitude and even awe! What we have accomplished here at St. Matthew's you have made possible. Just one little commercial: if you are not participating in **FaithDirect, please do so.** It's a simple process to register
